National Visa for Family Reunion Visa

- joining spouse, fiancé(e), minor child -

(Section 27 ff. Residence Act and Section 7 (1) Residence Act)

General Information

You are required to obtain a residence permit in the form of a visa if

ightarrow you are married/will get married to a foreign (non-EU) citizen

ightarrow you are a parent of a foreign (non-EU) minor child

and wish to seek gainful permanent residency in Germany.

Once all required documents have been submitted, the application and supporting documents will be forwarded to the Immigration Office at the intended place of residence in Germany. The standard processing time can take up to 12 weeks, but processing times can vary if additional documents are required. As soon as the application has been approved by the Immigration Office, the Embassy/Consulate will issue a national visa for the first 90 days of the intended stay. A final residence permit for a longer period will be issued upon arrival by the Immigration Office. A family reunion visa does also entitle its holder to enter other Schengen countries for a stay of up to 90 days for tourism purposes.

×	X	When applying for family reunion to join your foreign (non-EU) minor child → Birth certificate of your child
X	X	 Proof of German language skills at least level A1 when joining spouse or fiancé(e) Competency in the German language means that the applicant has the ability to communicate in German on at least a basic level, i.e. holds a certificate of successful completion of a German language course level A1 according to the Common European Framework of Reference for Languages. Certificates issued by an institution, which performs testing in accordance with the standards of the Association of Language Testers in Europe (ALTE), are accepted. These requirements are only met by the Goethe-Institute (www.goethe.de). → For possible exceptions from proof of language skills, please consult the website of the Federal Office for Migration and Refugees
	X	Supporting letter issued by the applicant's spouse/ fiancé(e)/the minor child's parent(s) to set up joint residence in Germany with informal declaration on how to secure livelihood in Germany
	X	Proof of financial means of applicant's spouse/fiancé(e)/parent or applicant itself e.g. employment contract or bank statements of the last 3 months
	×	Registration in Germany ("Meldebescheinigung") of the spouse/fiancé(e)/minor child
	×	Passports data page of the spouse/fiancé(e)/minor child
	X	Proof of adequate health insurance coverage Health insurance coverage is required at the time of entry into the Schengen area. Proof can be provided by presenting the health insurance policy of the family member for whom the reunification is taking place and a letter from the health insurance company stating that the person entering the country will be included in the family insurance upon entry.
