

Schengen visa for the spouse/parent of a German citizen

General Information

- The visa application can be submitted at the earliest six months prior to the planned trip.
- Documents that are not issued in German or English must be submitted together with a translation.
- Each visa application is reviewed individually. Therefore, the requested documents might vary. The Embassy reserves the right to request further documentation.
- Submission of an incomplete application may lead to a refusal of your visa application.

Visa application checklist

Please use the following checklist to make sure that your documents are complete. Please submit the documents listed below in according order.

×		Fully completed and signed application including and signed declaration
×		One (1) recent biometric passport photo (see specimen photos)
X	×	 Signed passport meeting the following requirements: a. Its validity must exceed the duration of the intended stay in Germany by at least 3 months b. It must contain at least 2 blank pages c. It must have been issued (not extended!) within the past 10 years
×	×	US alien registration card or valid US resident visa (type A, E, F plus endorsed I-20, G, H, I, J plus J1 document, L, O, R)
	X	Proof of address, e.g. valid driver's license, utility bill, lease
	X	Proof of relationship to the German citizen: a. Marriage certificate and/or b. Birth certificate
	X	Passport of the German citizen
X	X	 Proof of adequate financial means: a. Your Checking account statements of the last three months stating your name and address, b. If you are financially supported by your spouse: signed sponsor letter, bank statements, proof of relationship, passport copy We cannot accept bank statements for saving accounts, Travel Money Cards or cash as proof of sufficient funds.

	×	Confirmed flight (roundtrip)/travel reservations with the name of passenger
	X	Confirmed hotel reservations stating name, address and telephone of the hotel, including confirmation number as well as name of the guest
	X	 Proof of <u>travel health insurance</u> stating: a. Name of the applicant b. Coverage of at least 30,000 EUR for medical expenses and repatriation c. Validity for the entire Schengen area d. Validity for the entire duration of stay in the Schengen area Only insurance confirmation, no letters of employer, is accepted. The insurance has to be issued either in the US or in Germany.

Visa application fees

Processing fee:

Payable in cash only.
