

Information about Schengen visas

The common 'Schengen' visa is for a short stay (tourism, a family or friend visit, or for business) of up to 90 days in an 180-day period within the following countries:

Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Lithuania, Luxemburg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, Switzerland and Liechtenstein.

- As of 26 March 1995, Foreigners travelling to one of the aforementioned countries may receive a visa for a short stay of 1 to 90 days (maximum), which is valid for all these countries.
- There is no legal right to a visa.
- The visa application has to be presented to the Embassy /Consulate of the country of main destination (determined by the purpose of the journey and the length of stay). If you wish to visit several countries and therefore cannot ascertain a main destination, please apply with the Schengen country of first entry.
- Depending on the purpose of travel, different documents are required. Additional documents or information may be requested at any time.
- Furthermore, you must hold a valid Residence Permit for the USA.
- Processing time for a Schengen visa is generally 24 to 48 hours, in certain cases 14 days.

YOU DO NOT NEED A VISA FOR SHORT STAYS IN GERMANY IF YOU ARE A :

- citizen of the EU/EEA/EFTA;
- holder of a Service, Official or Special Passport from Bolivia, Chad, Colombia, Ghana, Philippines, Thailand or Turkey;
- holder of a Service Passport from the United Arab Emirates;
- holder of a Service Passport from Ecuador, Moldova (biometric passport), Ukraine (biometric passport)
- holder of a Diplomatic Passport from Albania, Algeria, Armenia, Azerbaijan, Bosnia & Herzegovina, Gabon (biometric passport), Georgia, Ecuador, India, Jamaica, Kazakhstan, Kenya, Macedonia, Malawi, Moldova, Mongolia (biometric Passport), Montenegro, Morocco, Namibia, Pakistan, Peru, Russian Federation, Serbia, South Africa, Tunisia, Ukraine and United Arab Emirates, Vietnam,
